**Abstract**

In the paper by Durruthy, Pomés, Farjardo & Dago [*Acta Cryst.* (1993), **C49**, 558–559], an N···N hydrogen bond was incorrectly described as intramolecular. After rerefinement of the structural model, a weak intermolecular hydrogen bond between a CN group of one molecule and an NH group of an adjacent one was established with N···N 3.113 (3), N···H 2.389 (3) Å and N—H···N 142.0 (1)°. The molecule

crystallizes in the *E* configuration.

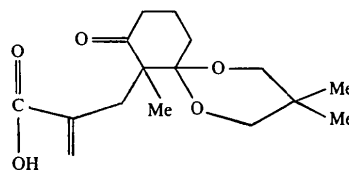
